

LAFD ACS NET SCRIPT

Revised March 11, 2015

QST, QST, QST. This is (*your call sign*), operating the N6ACS NET CONTROL Station for the City of Los Angeles Auxiliary Communication Service NET. This net meets every Monday evening at 1930 hours for the purpose of passing traffic to ACS members. Are there any stations with EMERGENCY or PRIORITY TRAFFIC?

Handle the traffic if any.

If none: Hearing none,

This is a **DIRECTED NET**, which means that members with relevant questions and comments for any ACS station are asked to wait for acknowledgement by NET CONTROL before sending their traffic.

The Los Angeles City Fire Department manages this NET for the Emergency Management Department of the City of Los Angeles. All amateur radio operators not affiliated with the Los Angeles City ACS are invited to monitor tonight's net or are requested to please take their traffic to another frequency until approximately 2030 hours this evening. Thank you.

Pause/reset.

When responding to roll call, stations are requested to follow net protocol by identifying their stations by tactical call sign followed by FCC call sign.

At the conclusion of the directed net, an open and informal roundtable will take place, at which time matters of a general nature or procedural questions and comments may be discussed. All amateur stations, including non-ACS members, are invited to participate.

This is (*your call sign*), operating the N6ACS NET CONTROL Station. At this time Net Control will call the ACS **Command Staff** for traffic.

Go to roll call command and member spread sheet

This is NET CONTROL calling **WD6AIS** – (*Chief Nida*) **Volunteer Coordinator and City Radio Officer for comments.** Over.

(Acknowledge WD6AIS.) Send your traffic.

Are there any questions for WD6AIS? (*Acknowledge stations and tell them to send their traffic.*)

This is NET CONTROL calling **K6LFD** — (*Mike Horst*) **Operations Officer** for comments. Over.

(Acknowledge K6LFD.) Send your traffic.

Are there any questions for K6LFD? (*Acknowledge stations and tell them to send their traffic.*)

This is NET CONTROL calling **KG6TRS** - *(Tom Wirth)* **Planning Section Officer** for comments. Over.

(Acknowledge KG6TRS.) Send your traffic.

Are there any questions for KG6TRS? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL calling **N6UOZ** – *(Mark Willardson)* **Logistics Section Officer** for comments. Over.

(Acknowledge N6UOZ.) Send your traffic.

Are there any questions for N6UOZ? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL calling **N6VI** – *(Marty Woll)* **Training Officer** for comments. Over.
(Acknowledge N6VI.) Send your traffic.

(Acknowledge N6VI.) Send your traffic.

Are there any questions for N6VI? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL calling **N6ZZK** – *(Ted Fukushima)* **Central Bureau Communication Unit Leader** for comments. Over.

(Acknowledge N6ZZK.) Send your traffic.

Are there any questions for N6ZZK? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL calling **KB6CNT**– *(Bill Coss)* **Valley Bureau Communication Unit Leader** for comments. Over.

(Acknowledge KB6CNT.) Send your traffic.

Are there any questions for KB6CNT? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL calling **KK6BMZ** – *(Fernanda Alves)* **South Bureau Communication Unit Leader** for comments. Over.

(Acknowledge KK6BMZ.) Send your traffic.

Are there any questions for KK6BMZ? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL calling **KG6NWJ**– *(Barry Colston)* **West Bureau Communication Unit Leader** for comments. Over.

(Acknowledge KG6NWJ.) Send your traffic.

Are there any questions for KG6NWJ? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL now calling **K6JGZ** – (*Jonathan Zimmerman*) the **LAFD CERT / ACS LIAISON COORDINATOR** for comments. Over.

(Acknowledge K6JGZ.) Send your traffic.

Are there any questions for K6JGZ? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL calling WD6FOX – (*Sean Fox*) the **Los Angeles Police Department / ACS LIAISON COORDINATOR** for comments. Over.

(Acknowledge WD6FOX.) Send your traffic.

Are there any questions for WD6FOX? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL calling N6ZZK – (*Ted Fukushima*) **N6ACS RADIO CLUB PRESIDENT** for comments. Over.

(Acknowledge N6ZZK.) Send your traffic.

Are there any questions for N6ZZK? *(Acknowledge stations and tell them to send their traffic.)*

This is NET CONTROL calling for any other station with business for the NET. Over. *Acknowledge stations and tell them to send their traffic. If any, ask: Are there any questions for (tactical call sign.)*

This is (*your call sign*), operating the N6ACS NET CONTROL Station for the City of Los Angeles Auxiliary Communication Service NET.

At this time, Net Control will conduct a **roll call of the active membership**. Active ACS stations will check-in in Battalion group order. Stations that do not check-in when their Battalion is called are requested to wait until the end of roll call when NET CONTROL will call for LATE or MISSED CHECK-INS.

Pause/reset

This is N6ACS Net Control now calling all stations in Battalion (*Insert Battalion Number Here*)

When each battalion is complete, continue as follows:

(Remember, there are no Battalions 3, 7, 8 or 16)

This is (*your call sign*), operating the N6ACS NET CONTROL Station for the City of Los Angeles Auxiliary Communication Service NET now calling for:.

Any **late or missed check-ins**, Battalion 1-10, Over.

This is N6ACS Net Control calling for any late or missed check-ins, Battalion 11-13, Over.

This is N6ACS Net Control calling for any late or missed check-ins, Battalion 14-18, Over.

This is Net Control calling for any CERT Check-Ins -- your FCC call sign please, Over.

This is Net Control calling for any Visitor Check-Ins via 2 meters or 220 Link, your FCC call sign please, Over.

This is N6ACS Net Control calling for any Echolink Stations, your call sign now and we'll wait a few moments for you to connect, Over.

This is Net Control calling for any **LATE BUSINESS** for the NET , Over.

If there is any business, ask for the traffic and then ask Are there any question for (Call Sign)?

Pause/reset

This is N6ACS, Net Control. We wish to thank the Radio Amateur Association of Van Nuys (RAAVN) for the use of their 2 meter repeater and the Baldwin Hills Amateur Radio Club for the use of their 220 link.
